Puppy Contract

Jagged Oaks Farm is happy that you have decided to add a new puppy to your family and we want to ensure that your puppy is in good health and free from disease at the time you pick your puppy up. All puppies come with a health certificate showing date of veterinary examination and vaccinations, which are provided by the breeder.

We require that your new puppy be seen by a licensed veterinarian of your choice at 12 weeks of age for second set of vaccinations and 16 weeks of age for final set of required vaccinations, so we may honor our one-year guarantee of a healthy puppy. Your puppy will be guaranteed against life threatening congenital defects of the heart, liver, and kidneys until one year of age. If your puppy is determined by a licensed veterinarian to have an above listed congenital defect in the first year of life, buyer may return the puppy, along with the written licensed veterinary report, and will be given a replacement with the next available puppy of equal value. Should death occur within the first year, a necropsy must be performed by a licensed veterinarian. Once a written report is provided confirming cause of death to be a congenital defect as listed above, breeder will provide a replacement with the next available puppy of equal value. Because we cannot guarantee against exposure to disease and viruses, we will find it necessary to void the one-year health guarantee if the licensed veterinarian examinations do not take place at 12 and 16 weeks of age.

Your new puppy can easily become stressed by change in diet, traveling, adjusting to a new home, etc., which can bring on problems including, but not limited to: hypoglycemia, coccidiosis/giardia, colds, URIs, worms, mites, etc. Once the puppy leaves the breeder, we have no control over his or her environment at that point. The afore-mentioned conditions are treatable and do NOT constitute a valid reason for returning the puppy to the breeder for replacement. Please note we do not cover malocclusion or misaligned bites.

NO REFUNDS will be provided. Should your new puppy meet the above conditions for a return to the breeder, **REPLACEMENT ONLY** of another puppy of similar value will be made when one is available. Returned puppies must be accompanied by all veterinary reports and vaccinations must be up to date.

All expenses incurred after the puppy leaves the breeder's care is the responsibility of the buyer. These expenses include, but are not limited to: veterinary care, supplies, necropsy, etc. This contract also does not provide any return or replacement provision for accidental injury. Accidents can happen and every effort should be made to ensure safe handling and a healthy, puppy-proof environment in your home. No guarantees are made as to size, color, personality, or temperament of puppy.

Your puppy has been raised on Purina Pro Plan Focus Chicken and Rice puppy food. Should a change in diet be desired, this should be done with the assistance of your licensed veterinarian. Breeder does not recommend changing this diet.

A non-refundable deposit of \$300.00 is required by Zelle to reserve a puppy. Puppy is to be picked up from breeder on the scheduled pickup day. A \$50.00 a day fee will be added if puppy needs to be boarded with breeder passed the pickup day. At the time of pickup, full payment must be made in CASH before the puppy goes home.

Please read the following three statements carefully:

1. Your new puppy is being sold as a **PET ONLY** and is not permitted to be bred under any circumstances.
2. You must spay or neuter your puppy within its first year of life.
3. If for any reason buyer is unable to keep the puppy, buyer agrees to return the puppy to Jagged Oaks Farm and not place the puppy elsewhere, unless first given permission by the breeder. **Breeder has first right of refusal.** If puppy is returned within the first 30 days, half of the purchase price will be refunded, which will be after the puppy has been placed in its new home. If puppy is returned after 30 days, there will be no refund given.
